

Minutes of the February 25, 2021 - Regular School Board Meeting

The Board of Trustees of the Coppell Independent School District, #057-922, met in a regular session on February 25, 2021 at 6:01 p.m. in the Board Room of the Vonita White Administration Building. The meeting was called to order by President Nichole Bentley.

OPEN FORUM

No community members came forward to speak in person or have statements read by a CISD staff member during the Open Forum portion of the agenda.

A hearing for public discussion of the Texas Academic Performance Report (TAPR) was held by Susie Williams, Coordinator of Accountability and Assessment.

DISCUSSION AND REPORT ITEMS - SUPERINTENDENT

Susie Williams (Coordinator of Assessment) presented the 2020 December STARR EOC results. Stephanie Flores (Director of Intervention Services) and Debbie Gauntt (Director of Intervention Services and Special Education) provided an Intervention Services and 504 updates. Superintendent Hunt shared a COVID-19 update. Dr. Greg Axelson, (Chief Operations Officer) provided an update on Bond Projects and Facilities. And finally, Diana Sircar (Chief Financial Officer) discussed the Budget.

CONSENT

David Caviness made a motion to approve the following consent agenda items:

Anthony Hill seconded the motion. The motion carried 6-0.

ACTION

Tracy Fisher made a motion to approve the TEA Missed School Day Waivers for February 15 – February 19, 2021, which is 5 school days, as recommended by CISD Administration. Manish Sethi seconded the motion and the motion passed 6-0.

A motion to approve the Resolution as presented to declare a public purpose for the expenditure of district funds for the pay period of February 13, 2021 and February 19, 2021 was made by Anthony Hill and seconded by Leigh Walker. The motion carried 6-0.

A motion to approve the changes to the 2021-2022 calendar as presented was made by Tracy Fisher and seconded by David Caviness. The motion passed 6-0.

A motion to approve the TEA Learning Hybrid Waivers for STAAR Testing during District testing days was made by Tracy Fisher. Anthony Hill seconded the motion and it passed 6-0.

Anthony Hill motioned to adopt the resolution authorizing the superintendent, or his designee to contract for the replacement, construction, and/or repair of school equipment and facilities necessary for the health and safety of district students and staff

due to the February 2021 winter storm. Tracy Fisher seconded and the motion passed 6-0.

George Williford with Hilltop Securities presented information on Bond Refunding to the Board.

A motion to adopt the Order authorizing the issuance of "Coppell Independent School District Unlimited Tax Refunding Bonds, Taxable Series 2021", establishing parameters for the sale and issuance of such bonds and delegating certain matters to authorized officials of the District was made by David Caviness and seconded by Tracy Fisher. The motion passed 6-0.
