

## **Minutes of the September 14, 2015 Regular School Board Meeting**

The Board of Trustees of the Coppell Independent School District, #057-922, met in a regular session on September 14, 2015, at 6:30 p.m. in the Board Room of the Vonia White Administration Building, 200 S. Denton Tap Road. The meeting was called to order by President David Apple.

A quorum was present.

Notice of this meeting was posted on September 11, 2015, at 4:10 p.m.

At 6:30 p.m., President Apple declared the Board in Closed Session, as authorized under the Government Code of Texas, as allowed by Sections 551.071 – Consultation with Attorney, and 551.074 – Personnel Matters.

President Apple declared the Board in Open Session at 7:30 p.m.

Anthony Hill gave the invocation and led the Pledge.

A motion was made by Tracy Fisher and seconded by Judy Barbo to employ professional personnel as recommended by the Superintendent. The motion carried 7-0.

A motion was made by Anthony Hill and seconded by Tracy Fisher to send notice of proposed termination of the identified term contract teacher pursuant to Section 21.211 of the Texas Education Code and Board Policies DFBA (LEGAL) and DFBA (LOCAL). The motion carried 7-0.

Anthony Hill made a motion to approve the recommendation to issue a finding in accordance with TEC §21.210(c)(2) and 19 TAC 249.14 (g) that good cause did not exist for a term teacher to abandon his/her employment contract and report the teacher to the State Board for Educator Certification. The motion was seconded by Susie Kemp and carried by a vote of 7-0.

## **CONSENT**

Tracy Fisher made a motion to approve consent agenda items:

Anthony Hill seconded the motion. The motion carried 7-0.

## **ACTION**

Thom Hulme made a motion to approve the Texas Education Agency “Request for Maximum Class Size Exception” (ten class section waivers) as required by the Texas Education Code §25.112 as presented. Amy Dungan seconded the motion. The motion carried 7-0.

Anthony Hill made the following statement and motions:

“I move that the Board adopt a tax rate of **\$1.1700** for the amount of taxes needed to fund maintenance and operation expenditures for the next year.”

“I move that the Board adopt a tax rate of **\$0.2690** for the amount of taxes needed to service the District’s debt.”

“I move that the property tax rate be increased by the adoption of a tax rate of **\$1.4390**, which is effectively a 4.73 percent increase in the tax rate, and that the accompanying Resolution setting the tax rate be passed and adopted by the Board of Trustees.”

“THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR’S TAX RATE.”

Tracy Fisher seconded the motions and statement, and all were approved by a vote of 7-0.
